During the meeting, the MS experts had the opportunity to discuss their questions and dilemmas with the IP lawyers, get answers and gain a deeper understanding of the national legislation and how it is interpreted and used in practice.

The IP lawyers on the other hand, had the opportunity to discuss the challenges they are facing while they are representing IP cases in court. It was a very fruitful meeting for both parties and it was agreed that further collaboration will take place in the future.
